If you are injured while at work, your employer has arranged for payment of your medical care with

IN CASE OF A WORK-RELATED INJURY OR DISEASE

IN ACCORDANCE WITH THE PENNSYLVANIA WORKERS' COMPENSATION ACT,
YOU MUST CHOOSE A MEDICAL PROVIDER FROM THE LIST BELOW:

If you suffer a work-related injury or disease, your employer or its insurance company will pay for reasonable surgical and medical services, medication, supplies, orthopedic appliances and prostheses, including training in their use.

In order to ensure that your medical treatment will be paid for by your employer or its insurance company, you must select from the one of the licensed physicians or practitioners of the healing arts listed below:

That the employee has the duty to obtain treatment for work-related injuries and illnesses from one or more of the designated health care providers for 90 days from the date of the first visit to designated provider.

That the employee has the right to have all reasonable medical supplies and treatment related to the injury paid for by the employer as long as the treatment is obtained from the designated provider during the 90-day period.

That the employee has the right, during this 90-day period, to switch from one health care provider on the list to another provider on the list, and that all the treatment shall be paid for by the employer.

That the employee has the right to seek treatment from referral provider if the employee is referred to him by a designated provider and the employer shall pay for the treatment rendered by the referral provider
